He has extensive experience in all aspects of the bankruptcy process, including stay relief, cash collateral usage, debtor-in-possession financing, lien avoidance, preference and fraudulent transfer litigation, asset sales, collateral auctions, valuations, plan negotiation, contests to confirmation, claims classification and voting disputes, objections to discharge, and third-party plans.

Greg also handles out-of-court workouts, loan modifications and collateral restructuring agreements, receiverships, replevin litigation, real estate foreclosures, secured party sales, and general commercial disputes. He frequently counsels lenders and institutional clients, providing timely and effective assistance with their most troublesome commercial and consumer loans.

He is a regular lecturer on bankruptcy and commercial litigation issues. Greg is an Adjunct Professor at the University of New Hampshire School of Law, where he teaches Bankruptcy Law and Practice.
