During law school, he worked in the Office of the Legislative Counsel for the U.S. House of Representatives. Following graduation from Georgetown Law, he was as a legislative assistant to U.S. Senator William D. Hathaway. He worked on health-related issues before the Senate Finance Committee and Health Subcommittee of the Senate Labor and Human Resources Committee.

In 1977, he was appointed Chief Counsel and Staff Director to the United States Senate Subcommittee on Alcoholism and Drug Abuse. In that position, he oversaw federal programs with annual budgets of approximately \$1 billion and coordinated the first Congressional hearing on fetal alcohol syndrome.
